Special Additional Conditions:

The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

The industries shall take all efforts to use and popularize "Mission LiFE" logo and mascot which is available in TNPCB & MoEFCC website. They shall also request their employees to adopt "Mission LiFE" action points and document the same and furnish half yearly report to Board.

Additional Conditions:

1. The unit shall ensure that no process emission is generated from the unit's manufacturing activity.
2. The unit shall ensure that the emission from DG Set satisfy the emission standards prescribed by the Board.
3. The unit shall adhere to the Ambient Air Quality and Noise level standards prescribed by the Board.
4. The unit shall continue to develop green belt by planting tall tree saplings (Kurunkadugal scheme) [spacing of 5 x 5 m for each tree and 5 to 7ft height] within the unit premises so as to cover 25% of the total area.
