Special Additional Conditions:

The unit shall obtain No Objection Certificate (NOC) from the Tamil Nadu Bio Diversity Board /National Bio Diversity Authority if the unit is using any Biological resources or knowledge associated thereto as per the provisions of Biological Diversity Act 2002.

The industries shall take all efforts to use and popularize "Mission LiFE" logo and mascot which is available in TNPCB & MoEFCC website. They shall also request their employees to adopt "Mission LiFE" action points and document the same and furnish half yearly report to Board.

Additional Conditions:

- 1. The unit shall treat and dispose the sewage through septic tank followed by soak pit arrangement.
- 2. The unit shall ensure that no trade effluent is generated from unit's manufacturing process.
- 3. The unit shall dispose the Non-Hazardous Wastes for further beneficial use without accumulation within the premises.
- 4. The unit shall not use "Use and throwaway plastics" irrespective of thickness such as plastic sheets used for food wrapping, spreading on dining etc; plastic plates, plastics coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags within the premises. Instead, the unit shall encourage use of eco-friendly alternatives such as banana leaf, Arecanut palm plate, stainless steel, Glass, Porcelain plates/cups, Cloth bag, Jute bag etc.
- 5. The unit shall comply with the E-Waste Management Rules 2022. E Waste as listed in Schedule –I, generated by them shall be channelized through collection centre or dealer of authorized produces or the dismantler or recycler or through designated take back service provided of the producer to authorized dismantler or recycler. The unit shall maintain records of c-waste generated by them in Form-2 and make such records available for scrutiny by the TNPCB. The unit shall file annual returns in Form -3, to the TNPCB on or before the 30th day of June in the following financial year.
- The unit shall not carry out manual cleaning of Septic tank under any circumstances and it shall be carried out using Mechanical Equipments.
